# **About the Unipetrol Foundation**

The Unipetrol Foundation started its activity in 2017. During the three years of its scholarship program, scholarships were distributed among 136 high school and university students in the fields of science and technology in the total amount of CZK 5 million. A total of CZK 370,000 was distributed to seven educators as part of the pedagogical grant. The grant program of the Foundation has already distributed CZK 5.5 million among thirty elementary and high schools across the country to support their educational and scientific activities.

#### The Foundation's activities constitute three basic pillars of support


The scholarship program is intended for students of natural and technical disciplines at secondary schools and universities. Under this program, for three school years it has already distributed scholarships among 136 high school and university students of science and technology amounting in total to CZK 5 million.



# Scholarship Program



The scholarship program is designed for talented students in the field of natural sciences with an emphasis on chemistry and technology.

During 2019, the Unipetrol Foundation handed over scholarships to high school and university students in the total value of CZK 1.56 million. The awarding ceremony took place on October 3rd at the Citadela community center in Litvínov with the participation of the members of the Board of Trustees of the Foundation and guests – Livia Klausová, Chairwoman of the Endowment Fund of Livia and Václav Klaus, and Jíří Šlégr, general manager of HC Verva Litvínov. Among the supported students there were also three from the youth hockey club Verva Litvínov and twenty two university students picked in cooperation with the Endowment Fund of Livia and Václav Klaus. In total, 48 scholarships were handed out.

# **Grant Program**



The grant program provides support for schools regarding education.

In 2019, the Unipetrol Foundation distributed grants among schools to support their science projects for the second time. In total, CZK 2.8 million was divided between 18 schools in 2019. The awarded schools included Masaryk's Secondary School of Chemistry, Mensa Gymnasium or T.G. Masaryk's Gymnasium in Litvínov.

# Pedagogical Program



The pedagogical grant is aimed at supporting and motivating teachers of chemistry and natural sciences in elementary and high schools.

The Unipetrol Foundation has prepared the Pedagogical Grant program in cooperation with the University Center UCT Prague - Unipetrol and with UniCRE, which was the initiator of the development of this grant program. The awarding ceremony took place on October 3rd at the Citadela community center in Litvínov, and the seven teachers who defended their above-standard approach to teaching before the Foundation Committee took over the grant. In total, CZK 370,000 was awarded to support innovative teaching methods in Czech schools.







# **Science Projects**

#### **Horizon Grand Prix**

In 2019, the Unipetrol Foundation supported the participation of six student teams in the Horizon Grand Prix program. The learning program is based on project teaching and enables students to acquire relevant knowledge and skills in science, technology and engineering. The aim of all competitors' efforts over several months was to construct a model of an electric car powered by a hydrogen fuel cell. The national finals took place in April 2019 in Prague and the international finals in June. The Unipetrol Foundation was represented by six school teams:

- Ecology and the Environmental Protection Secondary Vocational School Litvínov Schola Humanitas,
- Educhem High School in Meziboří,
- Secondary Industrial School in Brno Husovice,
- T.G. Masaryk's Gymnasium in Litvínov,
- Sedlčany Gymnasium and Secondary Vocational School of Economics,
- Secondary Vocational School and Secondary Vocational College in Neratovice.



#### **Wonderful Day with Chemistry**

In cooperation with UCT Prague and Unipetrol Center of Research and Education (UniCRE), the Unipetrol Foundation holds the event Wonderful Day with Chemistry, which was attended by more than 1900 children in 2019. The aim of the project is to show pupils of elementary schools and gymnasiums in a fun way that chemistry is a modern and attractive area, the study of which brings an infinite number of discoveries, and it is a great opportunity for future employment. The stars of this program are Michael Londesborough, Jan Havlík, Jakub Štěpánek, Michael Dragoun and Adéla Marschallová.

Already in 2018, WDC (Wonderful Day with Chemistry) has become the Foundation's flagship and other cities have also shown a huge interest in hosting this show. The project also has its own website, www.bajecnydenschemii.cz and the Foundation organizes it on the basis of orders from cities and founders of local elementary schools.



#### **EDUbus**

EDUbus, a unique mobile polytechnic laboratory, where pupils can try out a variety of chemical experiments in a fun way and take a peek at modern teaching of chemistry. The Foundation has been a partner of the project since its inception and was at its launch.

During 2019, the Unipetrol Foundation organized a roadshow at 20 schools in the Ústí Region.

The program offer includes a free afternoon workshop for educators conducted by the EDUteam with the support of the Unipetrol Foundation.



#### **4EDU Conference**

The conference on innovative education and its current trends called 4EDU, took place on October 3rd at the Citadel community center in Litvínov. Almost 300 participants, including teachers, school principals, school founders, students and the general public, attended a full-day program full of specialized lectures and workshops. The event was organized under the auspices of the town of Litvínov by the Unipetrol Foundation, the Litvínov Private Sports Elementary School and the HC Verva Litvínov hockey club.



#### **Fridays with Science**

"Fridays with Science" is a project of the Unipetrol Foundation in cooperation with the Josef Jungmann's Gymnasium in Litoměřice, which supports students' interest in science and research through regular lectures by prominent scientists.

In 2019, several prominent figures from the field of science and research have become part of the Fridays with Science project: Martin Růžička, Director of Development, Technology and Performance in the Unipetrol Group, who is in charge of the Research and Development Section, focused on the subject of Fuels Yesterday, Today and Tomorrow. Jan Havlík, an inorganic chemist and an enthusiastic promoter of natural sciences, introduced the audience to the subject of Synthetic Nanochemistry or Architecture in the World of Molecules. Doc. Ing. Zdeňka Kolská, PhD., specializing on surface properties of nanostructured materials. RNDr. Eduard Kočárek, Ph.D., academic and researcher at the 2nd Faculty of Medicine, Charles University, who is engaged in molecular cytogenetics. The latest guest of the Fridays with Science project is Ing. Václav Loula, an expert at the Czech Association of Petroleum Industry and Trade (ČAPPO), who gave a lecture on the issues of oil and fuels.



### **Chemical Swap Meet**

In its Chemical Swap Meet, the Unipetrol Foundation offers used laboratory and classroom equipment, small furniture and chemical consumables for teaching for free. These are chemistry teaching aids that are used but functional or with limited functionality. From the things offered, schools can select specific items and numbers of pieces as available.

In 2018, the Unipetrol Foundation donated decommissioned laboratory glass to schools for the first time. The Foundation holds the Chemical Swap Meet several times a year, depending on the volume of decommissioned goods.



#### **PC** Market

In 2019, the Unipetrol Foundation started a project called PC Market. This project lines up with the already existing Chemical Swap Meet, during which we donate to schools used but functional and safe chemical and laboratory equipment often unavailable to schools due to its high cost. For the same reasons, the Unipetrol Foundation decided to launch a PC market. Four schools received donations in 2019.





#### **Student Scientific Conference 2019**

For the fifth time, the University Center of UCT Prague-Unipetrol, which is located in the Unipetrol production site in Litvínov, held the Student Scientific Conference, sponsored by the Unipetrol Foundation since 2017. Student Scientific Conference (SSC) is an ideal platform and a unique showcase of scientific and research projects from talented students of high schools and universities not only from the Ústí region, but from the entire Czech Republic.

During the conference, 46 students presented their scientific and research projects in the area of science and technology, with an emphasis on chemistry.

Masaryk Secondary School of Chemistry in Prague had the largest representation, which took two victories out of four. All participants and authors of the best projects were commended by the Unipetral Foundation with monetary rewards in the total amount of CZK 120,000.



### Be Chic and Help

Be Chic and Help is the name of a Unipetral Foundation's campaign that the Foundation launched already in 2018 in cooperation with Kateřina Kaira Hrachovcová. This project continued in 2019. The proceeds from the sale of T-shirts were used to support the Grant Program for teachers. The actress and painter, Kateřina Hrachovcová, created the second T-shirt design and also participated in the campaign to promote its charity sale for the Foundation.



# **Special Projects**

#### **Uniriders Graceful Ride**

In 2019, the Unipetrol Foundation, HC Verva Litvínov and the Čepro company organized the first Uniriders Graceful Ride. On September 21, a graceful ride of more than two hundred and fifty motorbikes went through Litvínov, Most and the Bohemian Highlands. The event was connected with a charity fundraising event. The funds collected were fairly distributed to medical care for sick boys whose parents work for either the Unipetrol Group or Čepro. In total, CZK 108,000 was collected.

Specifically, one-third of the amount was be given to the family of 13-year-old disabled Roman who has other serious health problems, the second to the family of the mentally handicapped Jan, who is also physically limited, and the last to the family of the six-year-old Svatopluk, suffering from a skin disease called butterfly wing disease.



#### St. Nicholas Bazaar

During two December days, the Unipetrol Foundation organized an event called St. Nicholas Bazaar, the proceeds from which amounting to 20,923 went to the account of Ms. Jarka, who is battling a serious illness. The St. Nicholas Bazaar took place at Chempark in Litvínov on December 5th, 2019, and then in Prague on December 9th, 2019. The content of the St. Nicholas Bazaar was the sale of the T-shirts from the two collections by Kaira Hrachovcová under the Be Chic and Help project. The purpose was a public collection for Ms. Jarka, who has been battling multiple sclerosis since young age.



### Cooperation with the Unipetrol running club

In 2019, members of Unipetrol Group running club have run almost 3000 km during various races all over the country. The Unipetrol Foundation distributed CZK 194,000 among disadvantaged pupils and students. In 2019, the recipients were the F. L Gassmann Elementary Art School in Most, the organization Nové háro, the Astéri Endowment Fund, the students from Hamr Elementary School, who are facing a complicated life situation, and last but not least, a Unipetrol employee, whose son is severely ill and requires costly medical care.



#### Purpose (mission):

The purpose of the foundation is philanthropic and charitable. The purpose of the foundation is to make versatile contributions to the development of society and to improve the quality of life of people by promoting education at all levels of society, by promoting the improvement of the safety and health of people in society, by promoting the improvement of the environment and by promoting science, research and development.

### 2. General accounting principles

#### 2.1. Accrual accounting

The organization records deferred costs. Deferred costs are used for the accrual of costs that are related to following accounting periods. The organization does not accrue costs that are repeated each year and costs of negligible value, i.e. up to CZK 5,000.

#### 2.2. Received donations

The organization records received donations through the funds, and directly credits and debits them to account 211 – Cashier or 221 – Bank Account. The organization continuously records the distribution of donations in the form of foundation contributions by double entry to the foundation's debts and in favor of accounts 221 – Bank Account or 211 – Cashier, or in the form of use of donations for activity by a double entry to the foundation's debts and in favor of account 648 – drawing of the fund. The reported balance of the individual donation fund corresponds to the amount of unused donations.

#### 2.3. Public collection

In funds on account 911 – Public Collection Fund, the organization accounts for resources obtained from the public collection. On an ongoing basis, the organization accounts for the use of the proceeds of the public collection for foundation contributions to the foundation's debts and in favor of accounts 221 – Bank Account or 211 – Cashier, or in the form of use of donations for activity by a double entry to the foundation's debts and in favor of account 648 – Drawing of the fund. The reported balance of the public collection fund corresponds to the unspent amount from the public collection intended for further use, i.e. the balance of the collection bank account as at the balance sheet date.

#### 2.4. Received subsidies

Received subsidies are funds provided from public sources, i.e. mainly from the state budget, from the budgets of regional self-governing units, from state budgets of foreign states, etc. The organization accounts for these funds upon acceptance in the commitment accounts of group 34, or directly in revenues on account 691 – Subsidies. If the entire received amount of the subsidy is not spent by the end of the year, the remaining amount is reported as a liability in the account of group 34 – Liabilities against the state budget. In the event that more is spent within the subsidized project than has been received under the subsidy so far, the organization charges an estimated item to the debit of account 388 – Estimated items in favor of account 691 – Subsidies, so that the profit from the subsidy is always zero.

#### 2.5. Stocks

The organization records only purchased goods in stock — T-shirts that serve to promote the organization's key activity. Stock records are kept outside of accounting. Goods are recorded using the B method.

#### 2.6. Equity

The organization's equity consists of the contribution of the founder, UNIPETROL RPA, s.r.o., in the amount of CZK 500,000.00. The foundation's equity is a monetary expression of the foundation's principal, which consists of the founder's contribution described above. The equity includes funds and profit.

#### 2.7. Income tax

The main income (revenues) of the organization for the given period are received donations, which the organization in accordance with Section 19b of the Income Tax Act exempts from income tax.



#### 3.1. Assets and liabilities

The organization does not record any long-term or small assets. The organization does not record any long-term liabilities with a maturity of more than 5 years from the balance sheet date. It also does not record any assets or liabilities not stated in the balance sheet.

### 3.2. Employees and personnel costs

In 2019, the organization had one employee on the basis of work performance agreement. The total wage costs amounted to CZK 23,000, other personnel costs amounted to zero.

No remuneration or functional benefits were provided to the members of the governing bodies of the organization in 2019, nor were they provided with any loans, credits, guarantees or other benefits. The members of the governing bodies of the organization have no participation in persons with whom the organization entered into contractual relations in 2019.





#### 3.3. Received subsidies and donations

No subsidies were received in the accounting period. In the January 1, 2019 – December 31, 2019 accounting period, the following donations were accepted:

For the January 1, 2019 – December 31, 2019 accounting period, the organization reports an economic result of CZK 0. The tax base is CZK 0, the deduction according to Section 20 par. 7 of the Income Tax Act was not used. In accordance with Section 38mb of the Income Tax Act, the organization did not file a return for income tax for 2019.

# 3.7. Significant events between the balance sheet date and the date of preparation of the financial statements

At the end of 2019, there were first news from China regarding COVID-19 (coronavirus). In the first months of 2020, the virus spread worldwide and negatively affected many countries. Because the situation is constantly changing, the organization's management is currently unable to reliably quantify the potential impacts of these events on the organization. Any negative impact, that is losses, will be included by the organization in the accounting and financial statements in 2020.

The organization's management considered the potential impacts of COVID-19 on its activities and concluded that they did not have a significant effect on the assumption of the organization's ongoing existence.

Due to this, the financial statements as of December 31, 2019 were prepared on the assumption that the organization will be able to continue its activities.
